5. Pre-Bid Meeting shall be held at Suwarna Rural Municipality Office, Kawahigoth, Bara on 2:00 PM, 21st day from the date of notice published.

6. The Bid must be submitted on www.bolpatra.gov.np/egp on or before 12:00 PM (31st day from the date of notice published)

7. Bids shall be opened in the presence of Bidders' representatives who choose to attend at 2:00 PM on (16th December, 2021) at Suwarna Rural Municipality, office of Municipal Executive, Kawahigoth, Bara. Non-attendance of any or all of the Bidders' representatives shall not hinder the opening of the bids. Bids must be valid for a period of as mentioned in table below after the date of bid opening.

8. Bids must be accompanied by a Bid Security of minimum amount specified in table below either in the form of bank voucher confirming cash deposit in account no.as specified above or a bid security(unconditional bank guarantee) issued by "A" Class commercial Bank as approved by Nepal Rastra Bank. The Bid Security shall be *valid for 120 days* from the first date of notice publication. **Bidder must clearly quote the contract name and contract number in Bid security form (Bank guarantee) and also must be issued within the time period of notice publication otherwise will cause disqualification of Bidder.**

9. If the last date of purchasing and/or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case, the validity period of the bid security shall remain the same as specified for the original last date of bid submission.

10. Bidders can bid as a single contractor or in the form of Joint Venture of maximum of three contracting firms.

11. Bidders are advised to visit the site and assess the actual site condition before submitting the bids at their own cost.

12. The employer reserves the right to accept or reject wholly or partially any or all bids without assigning any reason, what so over.
